a) Approval of Agenda (or add items for discussion only) There was a last-minute action item added to the agenda on 8/20/2024. It was posted publicly and related to an urgent personnel matter. This item was added to closed session and will require a vote.

Mark Wheeler moved to approve the agenda as amended and was seconded by Stacey Hunter Schwartz. This passed unanimously.

#### II. Open Forum Catron

During open forum, each community member in attendance may address the Board for up to three minutes. Time guidelines ensure that all participants will have an opportunity to speak, as well as allow for the Board to resume their business in a timely fashion. #### a) Public Comment

The board received a letter from Red Slider, which has been provided to the members and will be included in the board meeting minutes. Red Slider is requesting options for two-way dialogue between community members and the CapRadio Team.

In the spirit of transparency, Susan stated that the Board will look into the current options for community engagement and will determine if they are adequate.

Kai Hahn, Sac State Alumni – Kai requested that CapRadio report on case # 99F08735, which relates to his father's death in an unsolved hit and run. He provided a packet to the members detailing the case and asked that it be included to the Board minutes.

Kai was informed of the newsroom firewall between the Board and the reporting staff. The Board cannot direct staff members to report on any items. Kai was referred to the CapRadio Newsroom email.

Mike Montgomery, former CapRadio Employee – Mike informed the Board that the trial for former Program Director Charles Starzynski's murder will be starting in a few days. Mike is requesting that CapRadio covers this trial to honor this individual.

Frank Maranzino stated that CapRadio covered this story when the murder originally occurred and expected that the Team will continue this coverage through the trial.

Bob Rosenberg, former Board member – Bob stated that he was glad to see the University's and President Wood's efforts in supporting the station. He complimented the move to take on Chico and Humboldt, and Frank's work in managing the CapRadio infrastructure up. CapRadio is blessed with a strong base of people who care. Bob stated that he was all for KVIE but they run a TV station and this is a radio station.

	a) General Manager's Report CapRadio has officially signed an agreement with the CA Intern Network. Timing for interns to be onsite is still up in the air but steady progress is occurring. 	Staff members met with the SacState student radio station KSSU to develop a master class on radio broadcasting.	
	There have been a number of recent hirings that have caused a 20% expansion in the Newsroom. Keyshawn Davis was brought on as CapRadio's new Communities Reporter. A temporary hire was added to help cover Insight for the next 3 months as Vicki Gonzalez continues to recover. The Wildfire Reporter position, which we had been struggling to fill, was accepted by an internal hire, Ava Norgrove.	
	Collective bargaining continues and seems to be going well.	
	In fall, SacState will be working with CapRadio to hold a learning lab at 1010 8 <sup>th</sup> Street. The goal is to utilize this space for students to learn how to hold events, manage equipment, and provide client-focused hospitality. The first event is currently scheduled for early November.	
	b) Chief Marketing and Revenue Officer's Report After the forensic exam release, CapRadio held five donor convenings over two weeks (around 15 people per convening) with key staff including Frank Maranzino, Chris Bruno and Jennifer Halm. The meetings went very well, and the general sentiment was that donors had more confidence than ever in CapRadio's new management and the future of the station.	Bruno
	Management is entering Phase II of the communications plan after the forensic examination, which will focus on amplifying CapRadio's turnaround story. Chris prepared a reference document for board members to effectively tell the story of the new CapRadio and dispel misinformation.	
	CapRadio's fall fundraising campaign starts on Aug. 28. It's typically the largest fundraiser of the year, and will include a significant matching funds gift to inspire the community to support the future of CapRadio.	
	Martin Clevenger inquired about social media engagement and how it's managed on the CapRadio side i.e., are staff responding to comments on social media? Chris informed him that staff does not respond to comments on social media, but instead take the larger reoccurring points and respond to those on the CapRadio.org/facts landing page.	
	Martin seeded time to Bob Rosenberg – In regards to outreach, the lease for the KXPR Eagles Nest Tower allows CapRadio to hold outings for donors at that facility. The station should consider it as an option for hosting future outreach events.

RE: Request for CapRadio to implement an open, public discussion page on all matters related to the operations and conduct of Capital Public Radio

DATE: 7/16/24

On behalf of the listeners and subscribers of Capital Public Radio we request the following matters be placed on the agenda of the next CapRadio Board meeting and receive consideration for immediate action:

- 1. That the CapRadio Board of Directors instruct CapRadio to cease holding announcements and posts from CAPRADIO DISCUSSION in "pending" or other non-posting status on its Facebook pages and allow CAPRADIO DISCUSSION messages to be posted without delay.
- 2. That the CapRadio Board of Directors instruct CapRadio management to create an open, public discussion page where its listeners can post and comment on any matters related to station affairs and share with others their concerns, suggestions and ideas. That venue should be conveniently and visibly linked on CapRado's website pages as well as on any Facebook pages it maintains. It should be open to the public to discuss station related matters and require no qualifications, account logins or other barriers to free, open discussion among CapRadio listeners and subscribers.

This letter repeats a request that has been made to CapRadio for years on behalf of listeners and subscribers that Capital Public Radio provide a general discussion page on its website and/or Facebook where listeners can go and discuss openly, among ourselves, any concerns, criticism or suggestions we have about anything relating to our public radio stations. As well, we see this as a place where listeners can go to request information from CapRadio and CSUS regarding any aspect of station management, operations, finance and other subjects, that we may actively participate in the affairs of our station and the health of its future.

#### Background

For several years, requests, online and by other means, have been made to CapRadio to provide an open discussion forum for listeners and subscribers. These requests have either been ignored or refused. Typical of responses from CapRadio concerning attempts to comment on matters outside of their restriction on their Music page, that subjects be kept to musical interests.

"Hi Red. We don't publish commentary or op-eds on our website or our Facebook page. However, you are welcome to reach out to our ombudsman to express your concerns, or to open this topic up to public consideration on your own page. You can email our ombudsman, Richard Zeiger, at rich.zeiger@capradio.org. Thanks again for your feedback!" (6/10/19)

On another attempt, CapRadio replied that they provide sufficient means for listeners to voice any complaints they might have, citing phone calls, emails, appearing in person at a board meeting, or sending the station a letter. What should be obvious from that list is that everyone of those means of expressing concerns is a one-way communication to the station. The station operates as a virtual black box via the listener. No one but CapRadio really knows anything about what the station does with such communications or even if they are seriously discussed. Certainly we are not privy to such discussions if they are. The fact that the station may assure us, "We take all communications from the public seriously," is no assurance at all. Any business can say that and the public has learned it can place little trust in such assurances without credible evidence of how their concerns have actually been handled.

For a brief period after the media announcements of CapRadio's financial difficulties and questions raised about the management of the stations, CapRadio Music did permit some discussion of that situation and some listener's concerns on its page. That lasted a few short months. CapRadio then posted a new set of rules for the group forbidding discussion outside the topic of music. In introducing their new rules, they stated quite plainly,

"If you would like to discuss other topics outside the scope [music] of this group, please choose another venue."

On April 30<sup>th</sup> of this year, I took CapRadio up on its offer and opened up a Facebook page "CAPRADIO DISCUSSION" to serve as an interim public venue where listeners could openly discuss among themselves any concerns, critique, or suggestions they might have related to the station. I made a few announcements on CapRadio that such a page existed and that listeners and subscribers were free to use it for those purposes. Not long after that, CapRadio altered its new Rules and removed its invitation to "please choose another venue". Following this, announcements to CapRadio's pages made by CAPRADIO DISSCUSSION to let listeners know of its existence were placed in indefinite "Pending" status. That means they are being censored solely because CapRadio doesn't happen like discussions which may be unfavorable or critical of the station.

This has happened before, the use of this "Pending" form of censorship which CapRadio employs. At that time we were forced to notify President Wood and Chancellor Garcia in order to get CapRadio to post announcement from and about CAPRADIO DISCUSSION. I note that, unless your Board instructs CapRadio management to post announcements from CAPRADIO DISCUSSION on its CapRadio Music page without delay, I will again have to needlessly bother the President and Chancellor about this matter. One of our current announcements has been held up since June 16<sup>th</sup>.

That is a brief glimpse of how CapRadio has responded to any proposals that might include listeners and subscribers as active participants in the health and future of our station, other than as revenue streams of support.

### Closing Remarks

It has been the pattern and history of CapRadio to exclude listeners from actively participating and contributing to the affairs and agenda of the stations. Perhaps this is to be understood, given what was revealed in the first audits of the station, and in what might be expected to be further exposed in continuing investigations in the future not only on their mismanagement of station finances, but in other matters pertaining to how they managed our stations. In the past, CapRadio has clearly been operating in its own self-interest rather than serving in the public interest. Their chief interest has been in acquiring subscriptions and donations (excluding the fact that many hosts, former and present, have tried their best to provide a good listening experience for their audiences.)

Perhaps it could be said that there was a time when the stations had no option but to operate as a virtual black box, limited to accepting communications on a many-to-one basis. Those days, however, are long gone. We now have the tools to create public discussion forums. On facebook, they are free, easy to set up and maintain. CapRadio already uses them for presenting its 'Music' page. For any entity that proclaims its core mission is "to serve in the public interest", there is no excuse for excluding the public from having an active and direct role in that mission.

CapRadio's refusal to implement such an open discussion page, after repeated requests, and its attempts to censor and hide any activity on the part of listeners to provide for themselves what CapRadio will not, is not only inexcusable, it raises the question of whether CapRadio is really "New", or remains a culture which protects itself above all, circles its wagons, and does not wish to know what listeners think other than praising the station (especially around pledge month and license renewal time.) What CapRadio does offer are endless on-air announcements about how "the station has changed", but provides no evidence of this. Certainly not in how it manages listener communications.

This is something the CapRadio Board of Directors can easily fix. If they expect listeners to believe the frequent on-air self-promotions about how the station has "corrected for past mistakes", then approving the two proposals made here would certainly be a good place to start. If CapRadio wants listeners to have confidence in their stations, then it will need to show confidence in their listeners. If the "new Board" is really new, then we cannot see how you can do otherwise than acknowledge the role its audience plays in determining the future health and importance of public radio to our communities.

Post/Announcemement attempted to CapRadio Music Facebook page by 'CAPRADIO DISSCUSSION' group on June 16, 2024. This post has been held in "pending" status by the administrators since that time.

#### TO CAPRADIO LISTENERS:

A reminder, if you have concerns, critiques or suggestions about CapRadio outside the subject of music, CAPRADIO DISCUSSION is a place you can post and discuss anything about the station and its affairs.

[note: 'CAPRADIO DISCUSSION' is not a substitute for CapRadio providing us with a public page where we can discuss among ourselves any topic related to the operation of our station and its agenda. It is only a temporary provision until/unless CapRadio provides us with such a venue, which it has so far refused to do for reasons unknown. Worth mentioning is that, if CPR did this, it might serve as a model for public stations across the nation. The days of requiring listeners to run to a board meeting, or phone/email their complaints or ideas into a one-way black box should be over. We have the tools to do much better than that, and it is time we used them.]

[comment: This announcement was made in response to CapRadio's invitation to "go to another venue" if we had comments outside the restricted topic, 'Music', on its page. We created such a venue, but when attempting to announce that and let listener's know of its existence, CapRadio def facto censors them by putting them in an indefinite "pending" status, having no intention of ever posting them to its Facebook page.

CapRadio is not only disingenuous in its claims to serve in the "public interest" by excluding the public from participating in that mission by providing an open topic, public forum, but also by inviting us to provide this essential public forum ourselves and then preventing us from announcing it to listeners on its pages. — red slider.]

Re: Political power interferes Sacramento Government and Grand Jury on criminal case investigation

Please include this letter to the meeting minutes today as a record

My name is Kai On and I am CSUS alumnus. 5-29-2024, I submitted a letter in person to Capital Public Radio (CapRadio) about two incidents that involves three CSUS alumni: Sacramento Police Chief Ms. Katherine Lester, CA State Assemblywomen Ms. Stephine Nguyen, and CA Secretary of Government Operations Ms. Amy Tong. Political power has been blocking me to 1. find out the truth of my father's death and the true defendant. 2. report my DMV payroll fraud and fake CalPERS retirement payment.

The people behind those two incidents my be related. I requested Ms. Stephine Nguyen for help in February 2024 but not until May 2024 could meet with her. However, political power blocked her to help me on those two incidents. CA Assemblymen Mr. Kevin McCarty who is running for Sacramento Mayor even refused to talk with me about SPD' fake investigation reports of my father's death.

Last year, I talked to CSUS journalism chair professor Mr. Mark Ludwig but he was blocked to help me and didn't refer me to CapRadio Radio. In 2022, I did talk with the CSUS student union members.

Mr. Nick Llanos, Mr. Governor and Ms. Amy Tong will appreciate if you can report my cases to them even this not your responsibility. I even received impersonate/fake CA State emails. I authorized Mr. Nick Llanos and CapRadio news team to get my "REAL" payroll tax history from EDD for investigation. Please invite Ms. Amy Tong to join the next meeting to discuss political power interferes CSUS academic independence and my two incidents. She was CA CIO, she can look into the fake emails. Please assign a reporter to report my public testimony at different meeting at Sacramento County and Sacramento City about my father's case. The Californians need to know about it.

My father's death case: My father was hit by a car and died at downtown Sacramento. I was given fake defendant name. Political power is blocking Sacramento County/City Officials, law enforcement, and Grand Jury to investigate fake DA Case information and fake Sacramento Police investigation reports.

Sacramento DA Office provided me fake court case information. Sacramento Police Department (SPD) provided me fake investigation reports. Both Sacramento District Attorney Mr. Thein Ho and SPD Chief Ms. Katherine Lester refused to confirm "Jone Soo Fong" was the driver who killed Woon Kwong On on 10-23-1999 at downtown Sacramento. I drove around in downtown Sacramento to find my father's death and talked to the officer on scene. The "Deed" of the grave of "Woon Kwong On" is under my name.

Sacramento DA Office's staffs didn't retrieve the court case file and bring the file to the meeting with me on 8-25-2023. It is skeptical and it prove the court case information is fake. The page 2 of this letter has the hand-written note from Sacramento DA Office and the page 1 of the fake report from SPD.

I met with SPD Deputy Chief Mr. Daniel Monk on 11-9-2023 and I mailed a letter to Sacramento DA Mr. Thien Ho on 1-11-2024 to request investigation but no action was taken. I went to Sacramento Board of Supervisors, Sacramento City Council, ethics commission and police review commission meetings in front of camera asking for help but I still couldn't get the real driver's name who killed Woon Kwong On.

I filed a complaint to Office of Attorney General (OAG) on 2-28-2024. I filed a complaint with County of

Sacramento Grand Jury but I got the respond are: 1. My complaint may not be investigated. 2. I may not be contacted . 3. I need to wait for the the Grand Jury final report on 6-30-2025 (next year).

I did provide the fake police reports and the hand-written note of the fake DA Case information to the Grand Jury. OAG and The Grand Jury can verify the DA Case file easy and fast. My father and my family is an ordinary immigrant family and have never involved in any political parties or businesses. The information of my father's death shouldn't be confidential and should be available to the public. It can prove the political power is interfering the justice system on the Grand Jury level. **Some untold stories?** 

I was CSU Sacramento student, CSUS and City College criminal justice and journalism professors refused to help. Sacramento Bee, KCRA3 and ABC10 refused to pull my father's news. ABC10 is only three blocks from where my father was killed. I am Chinese and I went to State Capitol, all Chinese Assembly Members refused to help. I also went to California Civil Rights Council for help in July 2024.

On 7-29-2024, Sacramento DA Office headquarter public counter law enforcement officer refused to take my Citizen Complaint Form. I refused to leave and asked them to arrest me so I can present the fake DA Case information to the judge at court. Then Sheriff officer, Mr. R. Loweny, Badge # 073, took my complaint form but he refused to sign on the form that he received my Citizen Complaint Form.

## My DMV (525-038) payroll fraud and fake CalPERS retirement payement

I was medical terminated from DMV in 4-4-2014. State Controller's Office (SCO) sent me form IRS 1095-C and SCO letters showed me I was fully employed in 2015 and 2016 by DMV. I didn't receive any direct deposit or pay check from SCO in 2015 and 2016 and I haven't worked since 2014.

CHP officer stopped me to report my DMV payroll fraud and submit crime evidences to CA State Auditor;s Office on 31 January 2022. The CHP dispatch report shows Board of Equalization requested the service but not CA State Auditor's Office, it is suspicious and it means someone from California State has been following me. If not, how Board of Equalization knew I went to CA State Auditor's Office.

I had requested State Controller Ms. Betty Yee and Ms. Malia Cohen's hand-signed signature to confirm my payroll history and the bank records of my payroll in 2015 and 1016. However, both SCO had never responded to me. How difficult is to have them to sign on a document that the information is true.

I also received impersonate/fake emails from CA State Agencies:

I have been blocked to contact CSU Sacramento alumna Ms. Amy Tong (CA Secretary of Government Operations) even I requested CSUS Alumni Association to help to contact her.

Please help to uphold the justice and let all California citizens know about these cases for a social justice! Fake information may be using to misleading Sacramento local government and Grand Jury. Thanks!

Next is the hand-written note from the staff of Sacramento District Attorney Office at 901 G Street, Sacramento, CA 95814 on 8-25-2023 meeting. Sac DA Office staff told me Sac DA Office doesn't have the information about my father's death but at the end of the meeting I was given the information on the right.

Why Sac DA Office staff didn't retrieve the DA Case # 99F08735 file before the meeting? It proves the DA Case is fake for my father' death.

On 01-11-2024, I mailed a letter to Sacramento DA Mr. Thien Ho to confirm my father's court case information but Mr. Thien Ho has never responded. On 4-9-2024, I also went to Sacramento Sheriff HQ to request Sheriff Mr. Jim Cooper to investigate, but I haven't received any respond from Mr. Cooper.

Next page has the first page of the fake investigation reports of my father's death provided by Sacramento Police Department and the form SPD810. There are many skeptical points about the reports.

- 1. SPD Chief Ms. Katherine Lester refused to confirm the driver's name that killed "Woon Kwon On".
- 2. SPD Capitan Mr. Brain Kinney refused to bring the reports to the Sacramento City Council meeting to show them in front of the council members and in front of camera during the video recording.
- 3. SPD already indicated on the Form SPD810 that report 99-83081 is not for my father's case and report 99-83121 doesn't exit. The report # was fill out by SPD staff. My request form was denied with reason "Rpt/WC". There a note on the form "WC Cantonese".
- 4. Report number 99-83081 is a CHP Traffic Collision Report and is State Highway Related. Woon Kwong On was walking from 819 U Street to 6th/W Street. How was it related to State Highway?
- 5. On page 14, the report number was altered. Also, "PARTY" 1, 2 and 3 are missing on page 1 of the report 99-83081 (CHP Form 55?).
- 6. There are 8 pages of Form SPD104, 15 pages of Form SPD105, 2 pages of Form SPD105A, 1 page of Form "Report Supplement" inside the report 99-83081. The Victim Field are all blanks on all 26 pages of SPD Form. The name Woon Kwong On was not on all those SPD Forms.
- 7. No page states "Jone Soo Fong" was the driver that killed "Woon Kwong On" on SPD forms and CHP forms. The report conclusion only used "VICTIM/PEDESTRIAN" but not "Woon Kwong On".
- 8. All emails from SPD Deputy Chief Mr. Daniel Monk and Capitan Mr. Brian Kinney never included and mentioned the name "Jone Soo Fong". .
